Intellectual property rights of work carried out at each partner institutions shall normally vest with respective institutions.

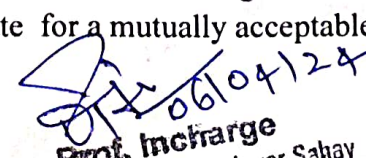
5. DURATION AND RENEWAL OF AGREEMENT

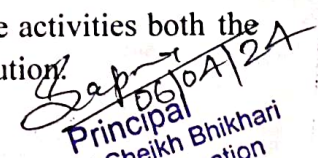
This Memorandum of Understanding will become effective immediately after signature by the representative of both colleges for a period of 05 Years and is subject to revision of modifications by mutual agreement.
